Motel/Hotel/Bed & Breakfast	\$315 minimum (\$10 per bedroom up to 40 bedrooms, \$8 per bedroom 41 bedrooms and over)
Resort	\$315 minimum (\$10 per bedroom up to 40 bedrooms, \$8 per bedroom 41 bedrooms and over, \$2 per campsite)
Campground	\$315 minimum (\$310 for the first 50 sites, \$2 for each additional site)
<u>Financial Depository</u>	\$315 minimum \$23 per million up to \$50 million in deposits (\$8 per million \$51-99 million, \$5 per million \$100 million and over in deposits)
<u>Second Business Membership/Same Owner</u>	\$200 per year (Excluding lodging. Payment options not available.)
<u>Associate Membership</u>	\$315 minimum (Available only to salespeople, representatives with firms, or businesses not located in the Bemidji Area or businesses located 40 miles or more from Bemidji.)
<u>Non-Profit Organizations</u>	30% discount on membership calculated on total full time equivalent employees.
<u>Individual Supporting Members</u>	\$60 each (Available to teachers, clergy, government employees, retired individ- uals, and other community members not otherwise engaged in busi- ness or professional ventures. Payment options not available.)

Membership investment in the Bemidji Area Chamber of Commerce may be tax deductible as an ordinary and necessary business expense, but not as a charitable tax deduction for federal income tax purposes.

Any amount less than the assessment will be considered a donation, not a membership.
