RULES AND REGULATIONS FOR A FUN AND SAFE PARADE

1. Entries must follow the theme of the parade with decorations and dress of the participants.
2. Vehicles and floats must decorate with Christmas lights and music must be Christmas music.
3. Candy or materials may **NOT** be handed out or thrown during the parade by entries or walkers.
4. All entries must observe safe conduct before and during the Parade.
5. Entries will not be allowed to perform routines that would stop or delay the parade.
6. Due to the noise, timing and surroundings, horses are not allowed in this parade.
7. No live impersonation of Santa Claus will be permitted. (Santa will conclude the parade on the 2017 winner's float.)
8. No live depictions of Christ on the Cross will be permitted. (You are welcome to celebrate the birth of Jesus.)
9. All entries must be approved by the Parade committee and the committee reserves the right to reject or remove any entry at any time for safety concerns, inappropriate behavior or at the direction of a parade marshal.
10. Only one vehicle per business/company should be entered.
11. Any deviation from the parade route will not be permitted.
12. Entries must be in place in the staging area no later than 6:30 p.m. (See #15 for staging information.)
13. Judging will take place along the parade route. **In order to be recognized, you must have your assigned number posted on the upper passenger's side of the windshield or front passenger's side fender. Your official Parade Number will be provided to you upon receipt of payment.** The number must be visible from a distance. If the number is not visible, the entry will not be recognized or judged.
14. There will be 6 categories for judging. Each category will be awarded a plaque. They are as follows:
Most Musical; Best Use of Lights; Best Religious Theme; Best Use of Parade Theme; Most Spirited; Best over All
15. North Wall Street will be closed to local traffic for the line-up of the Christmas Parade from 5:30 to 8:00 p.m. The parade will start at 7:00pm. Participants will enter on North Wall Street from Red Bud Road and proceed to Line Street. The parade begins at Line Street and ends at Oak Street.
16. All participants driving a vehicle must have an appropriately valid driver's license.

The application fee is \$20 per entry. School bands and public safety vehicles are exempt from the fee. All applications must be received by 4:00 p.m. on December 8. A late fee of \$10 must accompany applications after this date.
