Leadership Calhoun/Gordon County APPLICATION

Leadership Calhoun/Gordon County is sponsored by the Gordon County Chamber of Commerce. Its purpose is to provide leadership training to emerging community leaders. Opportunities are provided for participants to become more aware of community issues, needs, services and resources, and to be stimulated and motivated to use their talents and abilities to make our community an even better place to live, work and play.

*Leadership Calhoun/Gordon County begins with a weekend retreat in January for participants and their spouses. This will be followed by approximately eight sessions. The cost of the program is **\$425**. Participants arrange their own tuition or assistance by their employers.*

Leadership Calhoun/Gordon County Selection Criteria

- Application to Leadership Calhoun/Gordon County is open to persons living or working in Gordon County. Twenty-eight individuals will be selected to participate in the program.
- Class members are chosen by the Leadership Calhoun/Gordon County Program Committee on their own merits based upon the information completed on the enclosed application. The Committee seeks representation from a cross section of the community including business, labor, education, the arts, religion, government, community-based organizations, ethnic and minority groups.
- Nominees must have the full support of the organization or corporation they represent.
- **Attendance** at the retreat, the sessions, and graduation **is mandatory**.
- In reviewing applications, the Program Committee looks for potential participants who demonstrate the following criteria:
 - Commitment and motivation to serve Calhoun/Gordon County; personal history of community service and leadership.
 - Policy shaping responsibility or position of leadership in employment and/or volunteer organizations resulting in the potential to have significant influence on important issues facing the community.
 - Ability to make time commitment required by the program.
 - Interest in seeking public office, boards, commissions, or key volunteer leadership roles.
 - Likelihood of remaining in the community within the immediate future.
