V. TUITION FEE

A tuition fee is required to cover materials, monthly program expenses and retreat. Often employers are pleased to pay part or all of the tuition. If selected for participation, a minimum 50% deposit is due at the time of selection in June, with the balance payable no later than August 1. Tuition for Leadership Coweta is \$895.00 for Newnan-Coweta Chamber members in good standing, for employees of non-profit organizations and for community volunteers. Tuition is \$1095.00 for non-Newnan-Coweta Chamber members, which includes a \$200.00 credit towards a one-year individual Newnan-Coweta Chamber membership. **Initial Here _____**

VI. FINANCIAL ASSISTANCE

There are limited, need-based funds available to cover up to \$300.00 of the program tuition. Applicants who would like to be considered for one of two scholarships should draft a letter describing need and why you should be selected. Your request for consideration should be submitted as a separate attachment with your Leadership Coweta application. It will be held in utmost confidence, and will in no way affect the selection process. The Selection Committee will not be made aware of your financial assistance request until after class selection has been made.

VII. TIME COMMITMENT

Attendance Policy: The time commitment is for 9 monthly, one-day sessions and an overnight retreat beginning in June 2018. Attendance at all programs is mandatory. In addition, there is a class service project, leadership readings, two pre-program events, and occasional out of class assignments to go along with day programs. The time commitment is serious and participants not complying with the attendance requirements may be dropped from the program without tuition reimbursement. If selected, you and your employer must be willing to make a commitment of your time.
