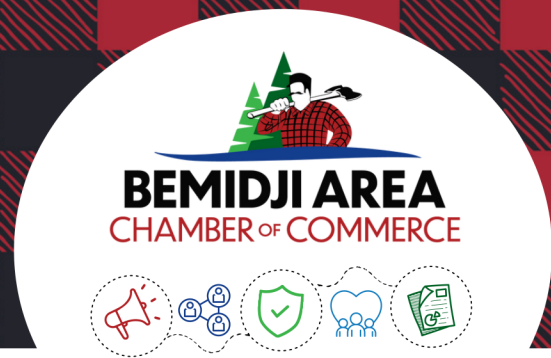


# ANNUAL MEMBERSHIP INVESTMENT RATES

## ASSOCIATE MEMBERSHIP

\$350 annual dues

Available to salespeople and representatives with businesses not located in the Bemidji area, or businesses located 40 miles or more from Bemidji.

## LODGING

\$350 base dues

+ \$10 per bedroom up to 40 bedrooms  
and \$9 per bedroom 41 bedrooms and over.

## ENTREPRENEUR MEMBERSHIP

\$175 annual dues

Available to new business established under 1-year, with no brick and mortar location, and employs under 2 FTE.

*\*Must provide proof of partnership with SBA, Greater Bemidji, or another local business consultant.*

*\*This dues rate is subject to increases and annual review.*

## FINANCIAL DEPOSITORY

\$350 base dues

\$25 per million up to \$50 million in deposits,  
\$9 per million for \$51-99 million, and \$6 per million  
for \$100 million and over in deposits.

## INDIVIDUAL SUPPORTING MEMBER

\$75 annual dues

Available to teachers, government employees, retired individuals, and other community members not otherwise engaged in business or professional ventures.

## NONPROFIT ORGANIZATION

25% discount on membership calculated on total of full-time equivalent employees.

*Chamber Membership dues are nonrefundable and may be paid monthly or annually.*

*Members on an annual payment plan will receive an annual renewal invoice. BACC Membership year is  
**September 1 - August 31.***

*All dues are tax deductible as a business expense. The Chamber accepts all major credit cards as payment.*

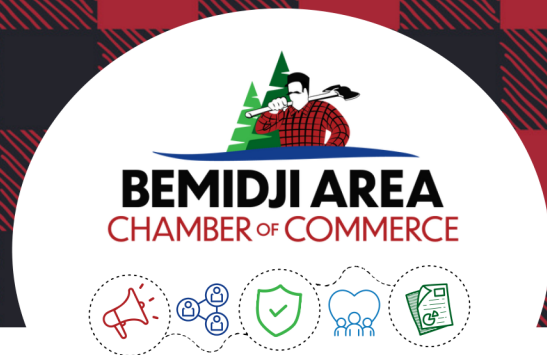

\$15 per month

Available to new business established under 1-year, with no brick and mortar location, and employs under 2 FTE.

## FINANCIAL DEPOSITORY

\$30 base dues per month +

\$25 per million up to \$50 million in deposits,  
\$9 per million for \$51-99 million, and \$6 per million  
for \$100 million and over in deposits.

## INDIVIDUAL SUPPORTING MEMBER

\$7 per month

Available to teachers, government employees, retired individuals, and other community members not otherwise engaged in business or professional ventures.
