# Hotels, Motels, Retirement Centers, Nursing Homes, Rehab Center, Urgent Care, and Hospitals:

Those who provide overnight accommodations, emergency care facilities, up to 24 hour care, walk-in and urgent care clinics, hospitals, centers and homes that provide living facilities for their patients/clients.

### Associate Membership:

An agent or individual that is working for a parent organization and HAS to operate under a broker type organization. The parent organization MUST be an active 'member', or the associate may pay the parent membership based upon total FTE within the fee schedule, for the parent listing.

Associate member can elect to use their name or the parent's name first in the listing, but the listing must include the parent business name.

Branches – multiple locations within our local business area with the 'same' name and Federal EIN.

### Non-Profit Membership: (Non-Voting Member)

Civic or Service Clubs, Charitable or Religious Organizations with documented paperwork (IRS determination letter). May join as a Business or Professional Member in order to be a voting Member.
