Total seating capacity as licensed by the occupational license and fire marshal.

Hotels, Motels, Retirement Centers, Nursing Homes, Urgent Care, Hospitals:

Those who provide overnight accommodations, emergency care facilities, up to 24 hour care, walk-in and urgent care clinics, hospitals, centers and homes that provide living facilities for their patients/clients.

Associate Membership:

An agent or individual that is working for a parent organization, and HAS to operate under a broker type organization. The parent organization MUST be an active 'member', or the associate may pay the parent membership... based upon total FTE within the fee schedule, for the parent listing. Associate member can elect to use their name or the parent's name, first in the listing, but the listing has to include the parent business.

Branches – multiple locations within our local business area, with the 'same' name.

Non-Profit Membership: (Non-Voting Member)

Civic or Service Clubs, Charitable or Religious Organizations, with documented paperwork. May join as Regular Member in order to become a voting Member.

Individual Member: (Non-Voting Member)

Not employed, not soliciting for a business for themselves, nor a non-profit organization.
