2017 DUES SCHEDULE

MARKETER MEMBERS: Any person, firm or corporation selling motor fuel, lubricants, groceries, candy, tobacco products to the ultimate consumer; including, wholesale and retail fuel distributors and wholesale and retail grocery & convenience retailers.

Dues for Petroleum Distributors are based on annual fuel gallons as reported by the Texas Comptroller of Public Accounts. Grocery Distributors dues are based on gross sales to customers in the state of Texas and dues for Grocery/C-Store Retailers are based on gross inside merchandise sales, excluding sales of lottery and motor fuels.

REFINER-SUPPLIER MEMBERS: Persons, firms or corporations engaged in refining of crude oil into petroleum products including gasoline, diesel fuel and lubricants. \$2,250

INDEPENDENT LUBRICANT MANUFACTURER: Persons, firms or corporations strictly engaged in refining of crude oil into lubricants. \$1,500

SUPPLIER MEMBERS: Persons, firms or corporations who provide products and/or services utilized by marketer members. \$ 600

TRADE ASSOCIATION MEMBERS: Non-profit organizations which are established to represent persons, firms or corporations engaged in the petroleum distribution, food distribution grocery or convenience store industries. \$5,000

INDEPENDENT OPERATORS: Persons, firms or corporations who exclusively own and/or operate no more than two retail motor fuel facilities. \$ 100

NON-GROCERY RETAILER: Persons, firms or corporations who are members exclusively to qualify for Workers Compensation insurance. \$ 100

SENIOR MEMBERS: Any individual who had retired from active participation in the represented industries and who has completed a minimum of ten (10) years as an active member of the Texas Food & Fuel Association, TGCA or TPCA. Includes spouse. \$ 100
