Expo Hours:

- FRIDAY, MAY 18 5:00 – 10:00PM
- SATURDAY, MAY 19 Noon – 11:00PM
- SUNDAY, MAY 20 Noon – 7:00PM

Booth Space: Tent spaces are 10 x 10 feet and roof. Each space includes an 8' table and two chairs. Expo tents are located on the Taste grounds. Exhibits must be contained inside the booth for safety and traffic flow. Expo booths are limited and are available on a first-come, first-served basis. No refunds. Chamber Members have first priority for expo registration.

Tent: Vendors who provide their own tent must properly weight down each post. Please call the office for details.

Signage: Exhibitors are responsible for their own signage. Please call the Chamber at 630-469-0907 for suggestions on Chamber member sign companies, promotional product sources, etc.

Sale of Merchandise: Exhibitors may **not sell or distribute Food or Beverages** in any manner. Exhibitors **MAY** sell merchandise, hold drawings, etc. from their booth.

Security: Exhibitors are responsible for their own booths. The Chamber will not provide security and will not be held responsible for lost/stolen articles or damages to booth or contents.

Hours: Exhibitors are required to staff their booth for the duration of the event for all days they are registered to exhibit.

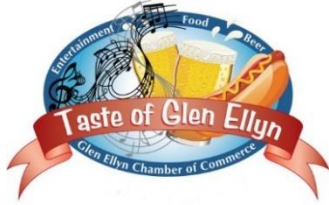
