## SELECTION CRITERIA

Application to the **LEADERSHIP MECOSTA PROGRAM** is open to all persons living or working in Mecosta County.

The class is generally limited to **35 participants** who will be selected by the **LEADERSHIP MECOSTA** Director and Steering Committee. The Committee will be seeking participation from varied business, ethnic, minority, age and gender groups to represent a cross-section of the community. Participants should be active in business, and/or non-profit, professional, educational, organized labor, governmental, artistic, religious, service or community organizations.

The most important factor in selection is identifying those individuals most apt to utilize their leadership for the long-term benefit of the community. In reviewing applications, the Steering Committee looks for candidates who demonstrate the following characteristics:

- Genuine concern for the future of Mecosta County and the region
- A sincere commitment, motivation and interest to serve Mecosta County and the region
- Currently in or potential for advancement to top leadership positions within their own organization
- Willingness and ability to make the time commitment required by the program
- The intention of seeking appointments to community boards, commissions or key volunteer leadership positions
- Representative of the diversity of the region

## ATTENDANCE REQUIREMENT

***Attendance and participation at the overnight retreat, all monthly classes, and in the class Leadership Project is a prerequisite for graduation. Participants may miss 1 monthly Class Session.***

## LEADERSHIP MECOSTA PROGRAM TUITION
