Guidelines for selecting “Lifetime Achievement” award recipient

The Lifetime Achievement Award recognizes an individual who has demonstrated exceptional business achievement and outstanding commitment to Weslaco’s business community over a sustained period of time.

A. Nominations

1. All entries/nominations must be submitted using the nomination form prepared by the Chamber staff (or nomination process approved by the WACC President/CEO) and must be at the Chamber office by a date set by the Weslaco Area Chamber of Commerce (Friday, October 19, 2018, 5 pm). Applications can be e-mailed to doug@weslaco.com.
2. Nomination Criteria:
 - Be a business leader in the City of Weslaco or have direct ties to a Weslaco project.
 - Be a current member of the Weslaco Area Chamber of Commerce.
 - Have participated in the Weslaco’s business community for a minimum of 20 years.
 - Have an established history of distinguished service.
 - Have made a lasting contribution to business and community development.
 - Exhibited leadership and provided inspiration to others in the community.
 - Earned recognition by other business, education, civic, or community groups.
 - Have the respect of professional peers.
 - General acknowledgement as having reached a pinnacle of their profession or industry.

B. Selection

1. Judging will be done by an Awards Selection Committee composed of former award recipients. The WACC President/CEO will serve as an ex-officio member who will not participate in the selection process.
2. In the event that selected committee members cannot serve, the WACC President/CEO will appoint other former recipients.
3. The Awards Selection Committee works confidentially at all times.
4. The Awards Selection Committee reserves the right to consider a nomination for another award.
5. The Awards Selection Committee may suggest an individual be nominated based on his/her volunteer work.

C. Announcement and Presentation

1. The announcement and presentation of a plaque will be made at the Chamber’s Annual Awards Luncheon to be held on Friday, November 2nd, at the Knapp Conference Center.

Guidelines for selecting “Man or Woman of the Year” award recipient

A. Nominations

1. The “Man or Woman of the Year” award will be presented annually to a Weslaco citizen who has served the community unselfishly over the last three years.
2. All entries/nominations must be in writing using a nomination form prepared by the Chamber staff (or a nomination process approved by the WACC President/CEO) and must be at the Chamber office by a date set by the Weslaco Area Chamber of Commerce (**Friday, October 19, 2018, 5 pm**). **Applications can be e-mailed to doug@weslaco.com.**
3. Nominations must be comprehensive and should focus on the service and accomplishments of the individual. For example, a strong nomination would indicate the years of service, involvement in major community projects worked on as an individual, but not as a member of the business entity; that is, John Doe’s employer allows him to volunteer time to projects. This would not merit the title of “Man or Woman of the Year”.
4. This is not a popularity award; rather, it represents recognition for one who unselfishly, and without need of personal gain, gives freely of their time and efforts to worthy causes in the community. The value of the contribution and service must not be as a result of political ties such as an elected official or one who is currently in a political race.

B. Selection

1. Judging will be done by an Awards Selection Committee composed of former award recipients. The WACC President/CEO will serve as an ex-officio member who will not participate in the selection process.
