Event Vendor Contract

This agreement is between the vendor and the Greater Fayetteville Chamber of Commerce and the event host Fort Bragg Harley - Davidson.

1. This event will be held on Saturday, October 14, 2017 at the Fort Bragg Harley - Davidson, 3950 Sycamore Dairy Rd, 11 AM until 5 PM.
2. **Vendor Load** – in will begin no earlier than 9 AM on Saturday, October 14, 2017 and run until 10 AM. The event begins at 11 AM, vendors should be set up/ready by 10:30 AM.
3. **Parking** - Vendors should unload and then immediately move their vehicle to the assigned parking area. There will be volunteers on site to assist you with unloading.
4. **Vendor load-out** must commence immediately upon close of show at 5PM. NO EARLY BREAKDOWN WILL BE ALLOWED
5. **Liability** – Vendor agrees to hold the Chamber and Fort Bragg Harley - Davidson and their agents and employees harmless from and against any and all losses, costs, damages, liabilities or expenses (including attorney's fees) arising out of or resulting from any accident, bodily injury, property loss or damage of the occurrences to any person or persons including the exhibitor's use and occupancy of the event exhibit or parking areas at Fort Bragg Harley - Davidson, or any part thereof.
6. **GFCC and Harley-Davidson** shall not be liable for any delay or failure to perform its operation, activities, shows and events to the extent such delay or failure results from a force majeure occurrence. A force majeure occurrence is defined as any occurrence arising from causes beyond the reasonable control of the Chamber and Harley - Davidson which delays or prevents performance by the aforementioned otherwise required by this Agreement, including but not limited to any (i) breakage or accident to equipment, machinery or facilities; (ii) any strikes, lock-outs or other labor difficulties; (iii) statutes, ordinances, regulations, orders, or rules issued by governmental authorities; (iv) judicial decrees or orders; (v) acts of God; (vi) animal diseases and/or quarantines; (vii) wars, riots or insurrections; (viii) civil disobediences, public demonstrations or sabotage; (ix) fires, floods, explosions or inclement weather; (x) inability to obtain necessary labor, materials, supplies, utilities or transportation; (xi) depressions, recessions or other economic downturns; (xii) embargoes or energy shortages; or (xiii) other causes beyond the Chamber or Harley-Davidson's reasonable control.
7. No Refunds – No cancellation of vendor contract will be accepted or refunds made after October 7, 2017
8. Insurance and Licenses: It is the Vendor's responsibility to obtain all necessary licenses and to follow appropriate procedures for reporting and submitting all taxes due.
9. ALL VENDORS MUST SIGN AND RETURN THIS SHEET to signify that they understand its terms.
