Drivers of ATVs must be **over 18** OR accompanied by adult.
All riders of ATV’s must sign the Parade Release Statement.

No Stopping during the parade to perform or pass out items (this causes a delay in the parade).

Absolutely No items can be thrown from entries.

All entries must have **Christmas decorations, lights AND music.**

All entries must enter off **Wharton St.** unless otherwise directed.

All entries must be **READY** by **6:00 P.M.**

ALL FLOATS MUST HAVE A FIRE EXTINGUISHER.

Release Statement

Participants agree to be solely responsible for any and all property loss or personal injury or any other claim or demand for damages as the result of or arising from our participation in said parade.
