It also places enormous liability on retailers who would be required under this bill to ensure that every piece of clothing sold into the California market that contains 50% synthetic material to have these California-only labels in two places. Prop 70		<p>Would require a one-time-two-thirds vote in each chamber of the CA state legislature to use revenue from the State Air Resources Board's auctioning or sale of greenhouse gas emissions allowances under the state's cap-and-trade program. To make sure no revenue is spent with the two-thirds vote, the measure would place all revenue from the cap-and-trade program in a Green-house gas Reduction Reserve Fund beginning 1/1/2024. Revenue would collect in this reserve fund until the one-time-two-thirds vote occurred.
