### **In order to apply, please submit the following:**

- ✔ Evidence of community service (minimum of 20 hours) **Use Attached Log**
- ✔ Submit a 500-750 word (three or more paragraphs) typed essay which addresses the following prompt: The mission of the Chamber of Commerce is to support businesses in the area and therefore positively influence and support the communities in which we live and work. With that spirit of giving back to our communities in mind, answer the following questions:
  - 1) Summarize your experiences with extra curricular activities and community service both in school and outside of school, including work, hobbies, and special interests. How do you believe your involvement makes your community a better place?
  - 2) Describe your future career goals. How do you believe your future career goals will positively give back to the community surrounding you?
- ✔ Provide three letters of recommendation from three separate individuals (i.e. teacher, counselor, business leader or non-familial community leader such as Scout leader, pastor, etc.) Note: only one letter can be from a current teacher and one letter must be from a community involvement supervisor/reference.
- ✔ Complete and submit the attached application.
- ✔ Submit school transcript of grades (if you are unable to provide proof of GPA or a transcript, please explain why and provide your ACT or SAT score on page 3 of the application)
