We cordially invite you to apply for the 15<sup>th</sup> Annual Mistletoe Market. This outdoor holiday shopping event will be in the footprint of the Summer Chesterton European Market, located in beautiful downtown Chesterton. Our goal is to make this year's Mistletoe Market more, European by creating an outdoor market. Outdoor Christmas markets are very popular in Europe.

Due to limited space (and in order to comply with fire codes), we will be unable to accept all applications for this year's event. We have decided that due to the popularity of the market, that we will give our European Market vendors the first right of refusal. If application and payment have not been turned in by October 15<sup>th</sup> your space will be offered to the next available vendor. Payment along with the application is due by October 15<sup>th</sup> to guarantee your spot. Additionally, electricity will not be available to anyone, aside from several food merchants and live musicians.

Mistletoe Market hours will be from 9a.m. to 3p.m. on Saturday, December 2. Set up will occur the morning of the event and can start as early as 6am.

**All accepted Mistletoe Market merchants must submit payment of \$60.00 per 10'x 10' space (\$65 for food merchants requiring electricity) prior to October 15. Failure to submit payment will result in the loss of booth space.** Cash, check or credit card may be accepted.

Merchants must bring their own tables, chairs and extension cords as needed. Tents are required to maintain the overall aesthetic appeal of the Market. Merchants will be assigned spaces to the best of the Market staff's ability to create seamless event flow and ambiance.
