## Guidelines & Information

**PLEASE inform all members of your parade entry.**

1. To facilitate the flow of traffic, all entrants **must** approach their numbered staging location from South San Jacinto Street via FM 20 West (State Park Road).
2. Entrants wishing to be eligible for Judging Awards must be in position at their numbered staging location **no later than 8:30 A.M.** All other entrants should be in position **no later than 9:00 A.M.** Movement from staging locations to Parade Route will be directed by Parade Staff at **9:30 A.M.**
3. Judging Awards are presented before the Parade begins, and may be displayed on the entry if desired.
4. To prevent injury to Parade spectators, **it is strictly prohibited for any object (flowers, samples, candy, etc.) to be thrown from a Parade entry.** This safety issue will be strongly enforced.
5. During the Grand Parade, please maintain a safe but consistent distance from the entry in front of you (2 - 3 car lengths is optimal).
6. The announcer's script is finalized and printed prior to the day of the Parade. If corrections to your original entry application are required, please contact one of the Chairpersons listed below well in advance of the Parade date. Please be **CONCISE** in your description. Announcer comments may be edited (or possibly omitted) as necessary to maintain proper Parade decorum and pace.
7. The Chisholm Trail Grand Parade always begins promptly at **10:00 A.M.**

**PUBLIC CONSUMPTION OF ALCOHOLIC BEVERAGES BY PARADE PARTICIPANTS IS STRICTLY PROHIBITED.**

***JUDGING WILL BEGIN PROMPTLY AT 8:30 A.M.***  
***To be eligible, entries must be in place with all participants at 8:30 A.M.***

Parking for horse trailers is available on Center Street in the parking lot of Navarro Elementary School.
