Maximum of 2 outlets per site—no 220-Volt outlet available—All electrical hook-ups (extension cords, power strips, etc.) must be legal and will be inspected by the City of Lockhart—All food vendors must have a fire extinguisher and sanitary washing water (soap, bleach & rinse water) Maximum of 2 foods per booth-Only 1 vendor will be selling hamburgers, tacos, etc. **ALL FOODS MUST BE PREPARED ON SITE** (foods are reserved as applications are received)**
