If your little girl wishes to participate she, along with her parents, must attend a meeting at the Lockhart Chamber of Commerce on Thursday, April 6, 2017 at 6:30 P.M. This meeting is very important, as raffle tickets will be given out and special instructions will be given to each participant and her parents. Parents will assume all responsibility for picking up raffle tickets and turning in money for sales.

The winner will receive a beautiful “Little Miss CTR” trophy and crown, along with an exciting prize package. The Little Princess and Little Duchess will also receive a trophy and crown.

The winners will be announced along with the winner of the CTR Queen contest at the Queen’s Coronation on Thursday, June 8, 2017 at 7:00 P.M., but please arrive no later than 6:30 P.M. The coronation will take place at the Main Pavilion at City Park.

Little Miss CTR, Little Princess, and Little Duchess will have the opportunity to ride the float along with the Queen’s Court and to represent our community at various Chamber activities throughout the year (see Parental Consent Form).

Hints, Tips and Suggestions

1. NEVER let your child sell raffle tickets alone. Accompany your child while doing door-to door sales, parking lot sales, etc. Safety should always be kept in mind.

HINT: Work with your candidate so she knows why she is selling raffle tickets and what a raffle ticket wins! Everyone loves a small child who will talk to him or her!

2. Turn your money in often! This will help keep the bookkeeping “headache” to a minimum. Please turn in checks you receive for raffle ticket sales within 3 days so we can get them through the bank.

HINT: Most people are paid on the 1st and 15th of the month. That is a good time to plan your selling strategy!

3. If you contact someone to buy raffle tickets from your candidate, be sure that you follow up on the sale. Each year we receive comments from people who get calls from candidates, who say they will come by to sell raffle tickets, but never show up.

HINT: If you have an appointment to meet someone to sell them raffle tickets and they are not there, have some ready-made notes that say, “We came by and sorry we missed you!” Be sure your name and phone number is on the note!

4. If someone says to you, “Mrs. Jones said that Suzy Jones has sold the most raffle tickets so far, and is definitely going to win!” Just look them straight in the eye and SMILE! No one will know who is leading at any time during the contest. The results will only be known after the final count.

HINT: Another candidate asks how your candidate is doing on raffle ticket sales, say “GREAT!” Remember that this is a fun competition!

5. If someone wants to help your candidate to sell raffle tickets, that is okay. Just remember YOU are responsible if they lose any money or raffle tickets.

HINT: If you give raffle tickets to a friend to help sell, keep a written ledger of who you gave them to, how many, and when (this will help you keep track of who has your raffle tickets).

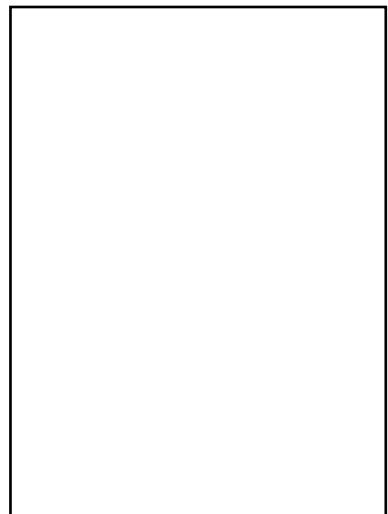

Raffle Tickets & Distribution

1. Raffle Ticket sales will begin after the Thursday, April 6 meeting. At the Kick-Off meeting, each “Little Miss CTR” candidate will receive 25 Raffle Tickets.
2. After the Thursday, April 6th meeting, all raffle tickets will be distributed by and all money turned in ONLY to the Lockhart Chamber of Commerce, 702 South Commerce. Raffle Tickets and money are handled in the following manner:

When you turn in money for raffle tickets you have sold, you will receive the equivalent amount of raffle tickets in return (for example, you turn in 25 raffle tickets and you will receive another 25 raffle tickets).

Money turn-in and raffle ticket pick-up will be available on MONDAY THROUGH FRIDAY, 9 A.M. until 5 P.M. at the address noted above.

A parent or legal guardian MUST sign for all raffle tickets received and all money turned in. Chamber of Commerce staff will count all money submitted in your presence, behind closed doors and you will sign verifying the amount.

3. Every raffle ticket has a value of \$6.00 and must be sold for only this amount. All money raised will be by raffle ticket sales ONLY. Fundraisers are allowed.
4. As the parent or legal guardian you are assuming personal and financial responsibility for all raffle tickets checked out in your “Little Miss CTR” candidate’s name. You are responsible for reimbursement to the Chisholm Trail Roundup for any lost or stolen raffle tickets and money from sales. Please be careful and turn in your money often.
5. The FINAL DEADLINE for the “Little Miss CTR” contest is Tuesday, June 6th at 12 Noon. All raffle tickets and money must be turned in at that time at the Lockhart Chamber of Commerce office. The cut-off time is strictly adhered to. You will not get credit for any money turned in after the Tuesday, June 6, 2017, 12 Noon deadline. You may turn in your candidate’s final money and raffle tickets in advance of this date and time by making prior arrangements at the Chamber of Commerce office.
6. Each candidate’s sales are strictly confidential during and after the competition. When the winners are announced at the Queen’s Coronation, individual totals will not be given. Please do not ask anyone associated with this contest for the “numbers.” They will not be revealed.
7. In the unlikely event of a tie, the tied competitor names are placed in a hat and a winner is drawn. Again, this will be strictly confidential.
