Food Vendor Information & Policies

The Greater Lake City Chamber of Commerce would like to thank you for your interest in being a food vendor at the 2019 South Carolina Tobacco Festival.

In order to make this event as enjoyable and prosperous as possible, a limited number of vendors will be accepted for each area where festival activities will be taking place. This will ensure greater variety of food items for our festival goers as well as an increased opportunity for vendors to profit. The submission of an application is not a guarantee of acceptance. We reserve the right to refuse acceptance of any application. All decisions are final. If you are not accepted to the event, your payment will be returned.

We require that you include picture(s) of your complete setup, its size, dimensions and a list of your menu items & prices with your application. **Food vendors are required to have a SCDHEC permit for temporary food service establishments and must comply with all local, county and state laws and must obtain a Lake City Business License.**

Food Vendors who are chosen for the Village Green/Henry Street area will be required to participate Friday evening, September 20, and all-day Saturday into Saturday evening, September 21. The spaces provided are approximately 10' x 20'; however, if your setup is larger you must let us know as we reserve the right to charge an additional fee if deemed necessary. Vendors chosen for the Village Green/Henry Street area will need to be set up no later than 4pm Friday and we ask that you not break down before the festivities are over Saturday evening (usually around 11pm). The fee for both days is \$300. Please be aware that there is no overnight security provided and that access to power & water is available on a very limited basis and not guaranteed.

Some food vendors will also be chosen for our Kids Zone area. Vendors for the Kids Zone area will only be needed on Saturday, September 21 and the fee is \$200. Set up should be complete by 8am Saturday morning and we ask that you do not begin breaking down before 5pm. Again, please be aware that access to electricity & water are not guaranteed and there is no overnight security provided.

There is an area on the top of the attached Food Vendor Application to indicate which vending area you prefer. Please clearly indicate your first choice. If you would also like to be considered to set up in another area(s), please indicate your choice(s) in order of priority. Although we will attempt to honor all requests, please be aware that space is limited and that decisions will be based on what we feel will best benefit everyone involved.

Applications must include a cashier's check or money order. **No personal checks.** If chosen, there will be no refunds of vendor fees under any circumstances. Deadline for applications is July 31. Any applications received and considered after that date are subject to a \$50 late fee.
