

Privacy Policy

Your privacy is one of our primary concerns. We are committed to bringing you information tailored to your individual preferences, while protecting your right to privacy. We do not share, sell or trade your personally identifiable information to any third party organizations. From time to time, we may notify you via email with special offers or news available to your interests.

Collection & Use of Personal Information

We collect personal information when you register for an account, when you use our products or services, when you visit our pages or the pages of certain partners, and when you enter promotions or sweepstakes. We use information for the following general purposes: to customize the advertising and content you see, fulfill your requests for products and services, improve our services, contact you, conduct research, and provide anonymous reporting for internal and external clients.

Your Access to and Control Over Information

Disclosure of Personal Information

We may disclose personal information if required to do so by law or in the good-faith belief that such action is necessary to: a) conform to the edicts of the law or comply with legal process served on us or our affiliates; b) protect and defend our rights or property or those of our users, and c) act as immediately necessary in order to protect the personal safety of our users or the public.

Communication Policy

We may send email newsletters and commercial messages to readers who have voluntarily opted to receive the products and provided their email address. Each email we send includes an "opt-out" link that users can use to remove themselves from the distribution list.

Confidentiality and Security
