Information:

The Arts & Crafts Show will be part of the Fiesta Street Festival on Ave. Del Mar in San Clemente. The entry fee is \$250.00 for Ave. Ola Vista area and \$350.00 to be on Ave. Del Mar per a 10x10 Space. Set-up time is 6:00 a.m.

The Fiesta will feature an arts & craft show. This exhibit showcases hand-crafted and unique merchandise from talented individual from Southern California. All items to be sold must be approved by the Chamber. Craft persons must provide their own equipment, handle their own sales, maintain cleanliness in their station and clean up at the end of the day, leaving the area as clean as they found it. *There will be no refunds for cancellations.*

All Vehicles must be off the street by 7:00 a.m. completely unload vehicle and park. Set-up of booth will take place after vehicle is parked. You must be completely set-up by 8:00 a.m. **Arrivals later than 7:30 a.m. will not be accepted, regardless of payment.** *Ola Vista Participants only:* Placement will be on a first-come, first served basis, there are no assigned numbers. Once you are set-up you may begin selling.

INDEMNIFICATION

1. Applicant shall indemnify, defend, and hold harmless the San Clemente Chamber of Commerce and The City of San Clemente, its officers, employees, and agents from any and all losses, costs, expenses, claims, liabilities, actions, or damages, including liability for injuries to any person or persons or damage to property arising at any time during and/or arising out of or in any way connected with Applicant's use or occupancy of facilities and adjoining property, unless solely caused by the gross negligence or willful misconduct of the San Clemente Chamber of Commerce and/or The City of San Clemente, its officers, employees, or agents.
2. Applicant shall report any personal injuries or property damage arising at any time during and/or arising out of or in any way connected with Applicant's use or occupancy of the San Clemente Chamber of Commerce and The City of San Clemente's facilities and adjoining property to the San Clemente Chamber of Commerce's Administrative Assistant, or her designee, in writing and as soon as practicable.

Applicant shall not charge results of "acts of God" to the San Clemente Chamber of Commerce and/or The City of San Clemente, its officers, employees, or agents.

Applicant waives any right of recovery against the San Clemente Chamber of Commerce and/or The City of San Clemente, its officers, employees and agents for indemnification, contribution, or declaratory relief arising out of or in any way connected with the Applicant's use or occupancy of San Clemente Chamber of Commerce and /or The City of San Clemente facilities and adjoining property, even if the San Clemente Chamber of Commerce and/or The City of San Clemente, its officers, employees, or agents seek recovery against the Applicant.
