**INDEMNIFICATION**

1. Applicant shall indemnify, defend, and hold harmless the San Clemente Chamber of Commerce and The City of San Clemente, its officers, employees, and agents from any and all losses, costs, expenses, claims, liabilities, actions, or damages, including liability for injuries to any person or persons or damage to property arising at any time during and/or arising out of or in any way connected with Applicant's use or occupancy of facilities and adjoining property, unless solely caused by the gross negligence or willful misconduct of the San Clemente Chamber of Commerce and/or The City of San Clemente, its officers, employees, or agents.
