

## The Greater Powell Chamber of Commerce Farmer's Market Rules and Regulations 2018

**Terms of Use:** The Powell Chamber of Commerce will organize and manage each market event starting 9:00am-12:00pm, **Saturday, May 12<sup>th</sup>, 2018 ending Saturday, October 27<sup>th</sup>, 2018.** Market will be located in the parking lot of 240 N. Liberty Street. *We will also include a preseason Market this year that will be in our outdoor location on April 21, 28 & May 5.*

All merchant/vendors (Merchant) will abide by the following:

- Each merchant will not hold responsible The Greater Powell Chamber of Commerce for damages or injuries to either personal property or assets to merchant during the operation of the market event. Waiver included in this agreement.
- Merchant shall provide the Greater Powell Area Chamber of Commerce proof of liability insurance (\$1 million minimum) as well as all applicable permits for Delaware County and the Ohio Department of Agriculture. **Powell Area Chamber of Commerce Farmers Market must be listed on your certificate of liability with a copy provided with your application.**
- **Merchant shall sell only items that are home grown, homemade or home baked (organic preferred); no wholesale produce permitted.**
- Merchant shall be responsible for the care of each lot and will ensure that all materials and debris (trash, palettes, vegetation, decorations, electrical equipment and furniture) will be removed when each Saturday event closes.
- There will be no smoking permitted on the grounds.
- No loud radios or shouting of prices.
- Merchant is solely responsible for any loss of personal or merchant property.
- **Merchant's agreement will be terminated immediately should the following occur:**
  - Merchant does not follow local or federal laws;
  - Merchant creates numerous complaints to the Powell Chamber;
  - Merchant fails to show to event without notification to the chamber office within 48 hours of event;
  - **Merchant fails to comply with this agreement.**
- Merchant is responsible for own water supply. Electricity and refrigeration are not available at the market.
- **Merchant will arrive at least 20 minutes before the event starts to prepare.**
- Merchant's name may be mentioned in Press Releases, Facebook and advertising occasionally to promote the farmers market.

### **Pricing for Merchant Space:**

12'W x 12'L (single lot) 24 weeks lease is \$250.00 (season)

12'W x 24'L (double lot) 24 weeks lease is \$350.00 (season)

12'W x 36'L (triple lot) 24 weeks lease is \$425.00 (season)

12'W x 12'L (single lot) 6 weeks (once per month) \$84.00 (season)

Week by week price is \$15.00 (prepayment arrangements must be made)

**\*\* NEW THIS YEAR ALL FEES MUST BE PREPAID IN ORDER TO GUARANTEE YOUR SPACE**

**Termination of Agreement:** Both parties agree to provide written notice of termination of this agreement 48 hours in advance.
