The term of office is for 3 years unless the candidate fills an unexpired term. The Board of Directors currently consists of 15 members. The Board of Directors meet once a month on the second Tuesday of the month at 8:30am. All members of the Board of Directors must attend monthly meetings, Chamber functions and volunteer their time and energy for various Chamber projects. The Board of Directors is expected to serve as positive leaders of the community and to demonstrate their commitment to the Chamber. The Board Member must be in good standing with the Canyon Chamber of Commerce.

We encourage our members to apply. Applicants are selected based upon service in the Chamber as well as background and experience. Unfortunately, we cannot accept every applicant, but we encourage you to continue to apply if you are interested.
