Ethics Policy Acknowledgment/Conflict of Interest Disclosure

The **Danville-Boyle County Economic Development Partnership (EDP), Inc.**, is a Special Purpose Government Entity (SPGE) defined and regulated under Kentucky Revised Statutes (KRS) Chapter 65A. As an SPGE with no “establishing entity”, the EDP’s board of directors, officers, and employees are subject to the Boyle County Fiscal Court’s Code of Ethics per KRS 65A.070(1)(c).

As a director/alternate, officer, or employee of the EDP, I acknowledge by my signature below that I have received a copy of and shall adhere to the Boyle County Fiscal Court’s Code of Ethics established by Ordinance No. 280.01 and amended by Ordinance No. 280.02. If applicable, I shall adhere alternatively to the Code of Ethics enacted for the City of Danville, the City of Junction City, or the City of Perryville to which I am bound as an elected official, appointee, or employee of one of these municipal jurisdictions.

Further, as a director/alternate, officer, or employee of the EDP, I also acknowledge that I have no personal, business, or professional relationship or interest that may present a conflict of interest in my service with or employment by the EDP, and if so, I shall disclose those potential conflicts in detail below.

I further acknowledge by my signature below that the EDP was created for the benefit of all citizens of Boyle County through the encouragement of job creation and capital investment through the EDP’s community and economic development initiatives. Therefore, I will endeavor to make all decisions as a member/alternate of the board of directors, an officer, or an employee of the EDP based upon the best interests of Boyle County’s economy without regard to any personal, business, or professional relationship(s) or interest(s) that I may have or may hereafter discover. If I do have or discover a potential conflict of interest regarding any issue before the EDP, I shall disclose the conflict in writing to my employer (in the case of an employee) or verbally to the EDP Board of Directors in an open meeting (in the case of a director or officer) and shall thereafter abstain from any participation, direction, influence, or decision regarding the issue (in the case of an employee) or voting upon the issue (in the case of a director or officer).
