Your JPEG Ad (800 pixels wide x 200 pixels high) will be linked to your company's website and placed under Member News.

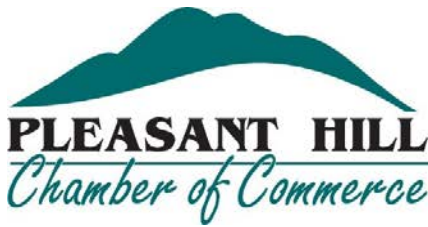
