- Vendor applications will be considered based on completed applications, product authenticity and relevance to the historic period.
- The Sublette County Chamber of Commerce (SCCC) reserves the right to assign final booth location.
- There will be NO REFUNDS for cancellations or no-shows after April 15, 2018.
- NO SECURITY. Vendors are responsible for securing all items, displays etc. related to their booth setup.
- ALL approved vendors must check in at the SCCC prior to setup. NO EXCEPTIONS! Check-In Wednesday July 11th, 2-5 p.m. or Thursday July 12th, 9 a.m. at the SCCC.
- Mail completed application with a check to SCCC- PO Box 176, Pinedale, WY 82941.
- Vendor must be in compliance with all town and state regulations.
