CPCC/HBL Havana Casino Night Agreement Terms and Guidelines

Sponsor agrees to the following terms and guidelines set forth herein and by such any amendments or additional terms and guidelines that may be established by the Central Pasco Chamber of Commerce of the Hispanic Business Leaders (CPCC/HBL):

1. Sponsor's participation is subject to all terms and guidelines established by CPCC/HBL.
2. CPCC/HBL shall not be responsible for any injury or loss that may arise to Sponsor or anyone that is accompanied by Sponsor, or to Sponsor's goods or property from any cause whatsoever.
3. Sponsor shall not share or sublet its Sponsor space or promote any other business without the express written consent of CPCC/HBL.
4. A non-refundable deposit of \$75 is required with the signing of this agreement. In the event the Event is cancelled for any reason, the deposit will be refunded.
5. Sponsor will not be permitted to participate in scheduled Event without full payment made prior to the beginning of the event. If payment in full is not received 7 days prior to the event date, CPCC/HBL reserves the right to reassign to another sponsor.
6. Sponsor shall hold harmless CPCC/HBL from any and all claims, costs, damages, losses, or expenses of any kind arising out of or from: Any accident or occurrence in or at the vendor's space, b) the sale of any products or services, by Vendor, its employee, staff or invitees.
7. CPCC/HBL reserves the right to cancel this agreement without further obligation at any time prior to the Casino date by releasing Vendor from all future obligations under this agreement. Said cancellation may be for any cause or for no cause. If a cancellation occurs due to fire or casualty beyond our control, CPCC/HBL will refund such portion of the amount already paid for space by CPCC/HBL after deduction of such amounts as may be necessary to cover costs related to termination. If for any reason, CPCC/HBL need to change the location or postpone the event, refunds will not be granted, but CPCC/HBL will assign to the Vendor, instead of the original space, such other space as CPCC/HBL thinks appropriate and the Vendor agrees to use such space under the same terms and guidelines. If the Casino Night is cancelled, postponed, or relocated, CPCC/HBL shall not be financially or otherwise obligated in the event except as provided herein.
