WAIVER AND RELEASE

WAIVER AND RELEASE (“RELEASE”) EXECUTED ON _____, BY _____ (“PARTICIPANT”) RELEASING THE WINDFEST COMMITTEE, THE PORTLAND CHAMBER OF COMMERCE, ITS OFFICERS, MEMBERS, EMPLOYEES, AND AGENTS, FROM ANY AND ALL CLAIMS OF PARTICIPANT ARISING FROM PARTICIPATION IN THE EVENT KNOWN AS **THE WINDFEST PARADE** (“EVENT”).

IN EXCHANGE FOR THE RIGHT TO PARTICIPATE IN THE EVENT, PARTICIPANT HEREBY WAIVES, RELEASES, AND DISCHARGES ANY AND ALL CLAIMS FOR INJURIES TO PERSON INCLUDING DEATH OR TO PROPERTY THAT PARTICIPANT MAY INCUR AS A RESULT OF PARTICIPANTS PARTICIPATION IN THE EVENT.
