



Bowman Design and Framing Presents Windfest 2017 Paint Portland Contest

Open to Children ages 3yrs – 18yrs old

Children's contest and supply packets sponsored by Dairy Queen (no entry fee)

*Each Artist will receive a one day pass to Windfest courtesy of the Portland Chamber of Commerce.*

Children's packets can be picked up during business hours after March 12th at Bowman Design and Framing 312 5th Ave. Portland, TX 78374 (while supplies last)

All submissions must be original works from the artist.

Limit of TWO submissions per child. Children's art work shall not exceed 8 1/2 inches by 11 inches...

The art should strive to depict people, places, plants, animals, environment, scenes, settings, events or activities relevant to PORTLAND Texas. Images or depictions not about the City of Portland and what can be found within Portland's borders shall be disqualified from the contest.

Children may submit Art work done in watercolor, finger paint or colored pencil. (Watercolor paints provided in child packets)

Any entry that contains the following materials will be disqualified:

- Obscene, lewd, profane, defamatory or inappropriate images or text, including nudity, acts of violence or acts that appear to cause harm.
- Any third-party materials; that violate or infringe (or may infringe) on any copyright, trademark, logo or other mark that identifies a brand, entity or other proprietary right of any person living or deceased (including but not limited to rights of privacy or publicity or portrayal in a false light)
- Other material deemed objectionable by Bowman Design and Framing in its sole discretion.
- Use of brand names, company names, and company or brand logos in the original art work.

All works must have the title, artist's name and telephone number on the back. All entries must be accompanied by a release and submission form which includes the artist's name, address, city, state, zip code, phone number, email address and the title of the work. In the event of a

dispute as to the identity of an entrant, the name appearing on the entry form will be deemed to be the entrant.

All entries may be used by the Portland Chamber of Commerce, City of Portland, and Bowman Design and Framing for the promotion or marketing of Portland, Texas. In addition, entries may be used in displays, websites, printed material or social media to promote the city of Portland or events at Bowman Design and Framing.

### **Copyright protection**

Under United States law, the author of a book, the artist who creates a painting or the creator of any other work, is protected by copyright law so that others cannot use those works without the creator's permission. Entrants must be certain not to use the work of others. An entry that uses a work that is covered by copyright without first obtaining a release will cause the entry to be disqualified from the contest.

### **Deadlines**

All entries must be received at Bowman Design and Framing 312 5th Ave. Portland, Texas 78374. All Entries must be delivered before 1pm Friday April 7th. Entries received after the deadline will be in eligible for consideration.

### **Contest judging**

Bowman Design and Framing reserves the right to determine whether entries are not accepted or disqualified. For the purpose of this contest, "not acceptable" shall be defined as an invalid entry that the entrant must correct to be considered valid, such as missing application information. "Disqualified" shall be defined as an entry that fails to meet the contest criteria described above. Disqualified entrants are not eligible to re-enter the contest. Citizens of Portland and Windfest attendees will be invited to judge the contest. In the event of a tie, Bowman Design and Framing will make an executive decision.

### **Judging criteria**

Judging will be done by popular vote in all categories.

### **Exhibition and Judging**

Exhibition and Judging of all entries will be at the Windfest Fairgrounds Location. Judging will be from Friday 6pm -9pm & Saturday 11:15am-9pm

Winners will be announced Sunday during Windfest.
