Paul Doyle is serving his sixth term representing the residents of the 9th State Senate District, which consists of the towns of Cromwell, Middletown, Newington, Rocky Hill, and Wethersfield. He currently serves as Senate Chair of the Judiciary and Regulation Review committees, as well as Vice-Chair of the Energy & Technology Committee. Senator Doyle also serves as a member of the Executive & Legislative Nominations and Legislative Management committees. For 12 years prior to his Senate service, Senator Doyle served in the state House of Representatives from the 28th Assembly District; he was House Chair of the Banks Committee and a member of the Judiciary and Commerce Committees. In 1997, Senator Doyle was selected as a Toll Fellow—a program that honors and acknowledges 40 individuals nationwide for their outstanding achievement and service to state government. Prior to his first election to the General Assembly in 1994, Senator Doyle was heavily involved in politics and government both at the state and local level. In the mid-eighties, Senator Doyle worked on the Democratic State Central Committee in Hartford as an executive assistant. Locally, he served as the Wethersfield Town Treasurer for two years before he was elected twice to the Wethersfield Town Council. While on the Town Council, he was Chair of the Transportation, Refuse Disposal, and Ambulance Committees; he was also liaison to the Wethersfield Chamber of Commerce. Senator Doyle holds a B.A. in History from Colby College and a J.D. from the University Of Connecticut School Of Law in Hartford. Senator Doyle also attended University College Galway (Ireland) and the University Of Notre Dame Law School (London, England). Senator Doyle lives in Wethersfield with his wife Diana, and has practiced law with several Connecticut firms. He is currently a partner in the firm of Heneghan, Kennedy & Doyle, L.L.C. in Rocky Hill.

Ted Kennedy, Jr. was first elected to the Connecticut State Senate in November 2014, and again in 2016, to serve the communities of Branford, Durham, Guilford, Killingworth, Madison, and North Branford. Ted brings with him a wealth of experience in the private and public sectors. Ted received his Bachelor's degree at Wesleyan University and graduated from the Yale University School of Forestry and Environmental Studies. He received his law degree from the University Of Connecticut School Of Law. In early 2014, Ted joined the national law firm of Epstein Becker & Green as a partner, working in the Health Care and Life Sciences practice. He advises health care providers, commercial insurers, and life science companies on critical issues related to health care reform policies. Prior to joining Epstein Becker & Green, Ted co-founded the Marwood Group, a leading healthcare-focused strategic advisory and financial services firm. Ted began his legal career at the law firm of Wiggin & Dana in New Haven, focusing on state and federal regulatory and reimbursement issues affecting hospitals, home care agencies, long-term care providers, physician practices and mental health providers. Ted also represented individuals with disabilities and created an ADA compliance practice to help businesses develop effective policies and guidelines. In addition, he served as the Director of Legal and Regulatory Affairs at the Connecticut Hospital Association, counseling acute care providers and policy makers on a wide array of emerging healthcare issues. Ted's commitment to healthcare issues began at an early age. Ted was twelve years old when he was diagnosed with bone cancer and needed to have his right leg amputated. Ted underwent months of intensive physical therapy and was eventually able to resume an active life including learning how to ski using adaptive equipment. As a teenager, Ted trained with the U.S. Handicapped Ski Team and won several national medals. After his experiences with surgery, two years of chemotherapy and learning how to walk with the use of a prosthesis, Ted understood how people like him faced a two-part struggle: the personal challenge of recovery and the public challenge of living in a society that did little to include people with disabilities. Since then, Ted has been a committed advocate for the self-determination and civil rights of people with disabilities. He served on President Reagan's Committee on the Employment of People with Disabilities, working with businesses to expand jobs. He has lectured nationwide and served as a study group leader on disability policy at Harvard University. He has worked with the bipartisan coalition of organizations in fighting for the passage of the Americans with Disabilities Act, signed into law by President George H.W. Bush in 1990. Ted has also served on the boards of numerous cancer and disability organizations, including Special Olympics International, the Connecticut's Office of Protection and Advocacy for Persons with Disabilities and, for the past 15 years, the board of the American Association of People with Disabilities (AAPD), the country's largest disability civil rights and public policy organization. Ted has presented keynote addresses both nationally and internationally on topics related to disability law, cancer and healthcare policy. Ted has lived in Branford for over 15 years with his wife, Katherine "Kiki" Kennedy, M.D., an Assistant Clinical Professor of Psychiatry at Yale University and environmental activist, and their two children, Kiley and Teddy.

State Senator Len Suzio (R-13) is serving his second term in the Connecticut State Senate. He represents the communities of Cheshire, Meriden, Middlefield, Middletown and Rockfall. Sen. Suzio serves as Co-Chair of the Committee on Children and Vice Chair of the Transportation Committee. He is also a member of the Finance, Revenue and Bonding, Judiciary, Veterans Affairs Committees. Sen. Suzio previously served as Ranking Member of the legislature's Select Committee on Children and on the Education and Appropriations Committees. Sen. Suzio has been a strong advocate for limited government and for no tax increases. In 2012, Sen. Suzio led the way in gaining bipartisan support for a cap to be placed on the state's rising gas tax. The law placing a cap on the gas tax was unanimously passed by the State Senate and State House. He continues to push for lower tax burdens, including the elimination of the state's tax on social security income and the prevention of the enactment of a Connecticut Mileage Tax. A strong voice on behalf of victims of violent crime, Sen. Suzio is a member of the State Victim Advocate Advisory Board. Sen. Suzio received top marks on the 2011 Environmental Scorecard issued by the CT League of Conservation Voters. He scored 100 percent for his support of a host of environmentally friendly laws. A champion for veterans' issues, Sen. Suzio led an initiative called "Give a Vet a Break, Get a Tax Break" which alerted area employers that there is now a state tax credit for companies to hire veterans. Sen. Suzio is founder and President of GeoDataVision, a bank consulting company specializing in the federal banking regulations. He previously worked as the Director, Executive Vice President, and Senior Loan Officer for American National Bank in Hamden. He also is a nationally recognized expert in bank regulations with a focus on the Community Reinvestment Act, the Home Mortgage Disclosure Act and the Fair Lending Regulations. Sen. Suzio was named Connecticut's "Small Business Banker Advocate of the Year" by the Small Business Administration in 1983. He has testified as an expert witness in small business finance at U.S. Senate Subcommittee Hearings on Small Business. He has also spoken at various regulatory compliance conferences including the American Bankers' Association and America's Community Banker Annual Compliance Conferences. Sen. Suzio served on the Meriden Board of Education for 14 years. He has also served as Vice President of the board of directors for High Hopes (a home for children with special needs) for more than 30 years. Sen. Suzio is the former President of the Kiwanis Club and a former director of the Chamber Orchestra of New England. He is the former President of the University of Pennsylvania Alumni Club in Connecticut. Sen. Suzio earned a degree in Economics and Finance from the Wharton School of Finance at the University of Pennsylvania. A Westbrook resident, Sen. Linares first became involved in politics as a volunteer for U.S. Senator Marco Rubio in Washington D.C.
