RULES & REGULATIONS

1. The Lodi District Chamber of Commerce (Chamber) expects the Artist(s)/Group (Artist) to perform in a “family friendly” manner and to always be in good taste for a diverse audience. In order to be in compliance with current copyright laws, the Chamber requires that the Artist perform music only in the repertory of ASCAP Clearance Express on their website at www.ascap.com and to verify that the music performed is ASCAP cleared.
2. Sound equipment and lights necessary for the performance will be provided by the Artist.
3. The volume of the sound must be conducive so other near-by vendors can conduct their business. You may be asked to turn down the volume by the Market Manager or his/her designee which will be done immediately.
4. Performance will begin on assigned date at 5:00 PM through 8:15 PM, unless otherwise approved/directed by the Chamber or Market Manager.
5. Breaks: One 10 minute break for each hour of performance is allowed unless other arrangements are made with the Chamber or Market Manager.
6. If retained to perform, the agreement of the Artist to perform is subject to proven detention by sickness, accidents, riots, strikes, epidemics, acts of God, or any other legitimate conditions beyond their control. If the Artist is unable to perform, the Artist will take reasonable measures to provide a suitable alternate Artist, who also must adhere to all of the Chamber’s Rules & Regulations.
7. During the hours of engagement when the Artist is not performing, the Artist will be responsible to provide background music, i.e. Ipod, CD through Artist sound equipment. All music needs to be ASCAP approved (see Item # 1 above).
8. Artist may be called upon to make public announcements as requested by the Chamber or Market Manager.
