RAINOUT POLICY: The Market will take place RAIN or SHINE. There are **NO** rainout refunds.

NO refunds after April 1, 2019; NO refunds due to non-participation or weather. We do not promise exclusivity but will use common sense in assigning spaces. There will be a \$35.00 charge on all returned checks.

Submitting this application is not guaranteed acceptance of your space in the market. Past participants will be given priority consideration if complete application and payment is submitted on or before the above date.
