### **PAW PAW FOOD VENDOR RULES**

- All food vendors should have their units in place between 5pm to 7pm on Friday, July 19.
- All food vendors will be responsible for trash in their area. Bring trash cans for use by your patrons.
- Food vendors may bring their own tables and chairs for use by their patrons.
- No camping. Village ordinance prohibits camping in public lots.

All food vendors should be inspected by the Van Buren-Cass County Health Department before opening in the morning at 9 am, Saturday, July 20, 2019. *You can reach the Health Department by calling (269) 657-5516. You are responsible for arranging for your own inspection. Booths which do not have the proper licensing will not be allowed to operate during the*

event. ***Food vendor fees are non-refundable -- the car show will be held rain or shine!***
