Membership Terms and Conditions

Membership fees for the Estevan Chamber of Commerce are payable in advance for the calendar year, and are non-refundable for twelve consecutive months for current members. For new members, rates are prorated for the remainder of the calendar year from the date of acceptance. All memberships will remain in force until revoked in writing. All corporate members are fully responsible and accountable for all actions of, and all charges incurred by, their designated Chamber representative(s). Membership fees are based on the number of employees in your company, including owners, managers and full-time staff (two part-time equal one full time employee for rating purposes). All employees can register for Chamber events at member pricing.

- Educational Institutions - Membership benefits apply to faculty, staff and board members of educational institutions. Membership privileges are not extended to students.
- Students & Individual Members - Students going to university or college on a full-time basis must provide a copy of their current student card. Individuals can join the Chamber providing they do not represent a company.
- Solopreneur is defined as a sole proprietorship or company that does not have any full time or part time employees and is run completely by one individual.
