**Please note:** Village of Germantown, Parade Permit, Ordinance No. 19-98; (10) CONDUCT OF PARTICIPANTS.

**No person shall commit the following acts** while participating in a parade in order to insure the safety of participants and spectators.

- (a) Possess or consume any alcoholic beverage on any float or vehicle.
- (b) Throwing any candy or other objects from any float or vehicle.
- (c) Operating a vehicle or float in an irresponsible or unsafe manner.
- (d) Boarding or departing any float or vehicle while it is in motion.

- \*All animal units are responsible for their own clean up along the parade route.
- Please provide your own signage.

GERMANTOWN AREA CHAMBER OF COMMERCE PARADE PARTICIPATION: RELEASE, WAIVER AND INDEMNIFICATION

In consideration for my being permitted to participate in, and/or my vehicle to be used in, the parade to be held in the Village of Germantown on November 10, 2018 (the "Parade"), I hereby agree to the terms and conditions set forth in this Release, Waiver and Indemnification (the "Release"); and, accordingly, I hereby state and agree as follows:

A) I am at least 18 years of age.

B) I will not knowingly permit an unlicensed driver to operate or use my vehicle in the Parade.

C) I acknowledge and understand that any insurance issued to Germantown Area Chamber of Commerce, or in which Germantown Area Chamber of Commerce is a named insured, will not protect me against a claim for damages or a lawsuit in the event of an accident involving my participation in or the operation or use of my vehicle in the Parade. I further acknowledge, understand and agree that any claim for damages made against me resulting from my participation in, and/or the use of my vehicle in the Parade will be my personal responsibility.

D) I acknowledge and understand that my personal insurance is the only insurance that may provide coverage for any and all events involving my vehicle, whether operated by me, a volunteer, village employee, or any other individual, in the Parade. I agree that I will obtain and maintain insurance coverage on my vehicle for the period of time in which I am involved in events relating to the Parade.

E) If my vehicle is licensed or registered with the Wisconsin Department of Transportation, Department of Motor Vehicles, I hereby represent and warrant that I carry at least the following minimum insurance coverage: \$100,000 (per person)/\$300,000 (per occurrence) Bodily Injury Liability; \$50,000 Property Damage Liability; \$100,000 (per person)/\$300,000 (per occurrence) Uninsured Motorist Bodily Injury Liability; and \$100,000 (per person)/\$300,000 (per occurrence) Underinsured Motorist Bodily Injury Liability.

F) If my vehicle is not licensed or not registered with the Wisconsin Department of Transportation, Department of Motor Vehicles, I hereby represent and warrant that I carry at least a minimum general liability insurance coverage of \$100,000 (per person)/\$300,000 (per occurrence).

G) I hereby agree to indemnify, defend and hold harmless the Germantown Area Chamber of Commerce and any and all of its members, officers and agents, and/or the Village of Germantown and any and all of its officials, officers, agents and employees, from and against any loss, demand, cause of action, liability, claim, obligation, damage, deficiency, cost or expense (including reasonable attorneys' fees and costs in connection therewith) resulting from, arising out of, or in any way connected with, whether directly or indirectly, my participation in the Parade and/or the operation and use of my vehicle by myself or another individual in the Parade.

H) I agree to not hold the Germantown Area Chamber of Commerce and its members, officers, and agents, and/or the Village of Germantown and its officials, agents and employees, liable for any injuries that I may sustain as a result of my participation in the Parade. I hereby release and waive any and all claims I may have against Germantown Area Chamber of Commerce and its members, officers and agents, and /or the Village of Germantown and its officials, officers, agents and employees, arising out of my participation in the Parade.

I) I agree to not hold the Germantown Area Chamber of Commerce and its members, officers and agents, and/or the Village of Germantown and its officials, officers, agents and employees, liable for any property damage to my vehicle arising out of the operation or use of my vehicle by myself or another individual in the Parade. I hereby release and waive any and all claims I may have against Germantown Area Chamber of Commerce and its members, officers and agents, and/or the Village of Germantown and its officials, officers, agents and employees, arising out of the operation and use of my vehicle by myself or another individual in the Parade.

I hereby acknowledge that I have read this Release and fully understand the contents hereof.
