Additional Dues Information:

Membership investment is deductible as a necessary business expense, not as a charitable contribution. Make sure to let your accountant know that you are a member of the Crete Chamber of Commerce.

Investments can be made annually and members will be invoiced during the first quarter of each year. Chamber of Commerce Annual Chamber Events and Sponsorship Opportunities

- **Annual Banquet**
 - This annual event is held in January. This event includes a social hour, dinner, brief annual meeting and awards presentation. During this event, chamber members are given the opportunity to see the accomplishments of the chamber in the year that has passed and view the goals for the following year.

- **Crete's Great Pumpkin Festival**
 - This weekend festival in downtown Crete is a weekend full of autumn fun. This community wide event is the Chamber's largest event of the year with an outreach of over 1,500 people on actual festival day. - **Firework Display**
 - This event is an annual firework display at the College Heights Country Club where donations from business help provide this community wide event for individuals to enjoy. Sponsorship benefits will be released later in the year.

- **Saline Solar Shadow**
 - Together the Crete Chamber is partnering with the Wilber Chamber of Commerce to host a weekend filled with events in both Crete and Wilber leading up to the Total Eclipse on Monday, August 21st. In both Crete and Wilber, downtown Main Street will provide spectacular viewing points, shopping tours, interactive events, educational presentations, food fair as well as a Band in The Street event in Crete on August 19th. Eclipse glasses and souvenir t-shirts will be available for great keepsakes from this memorable event. Additional schedule of events in Wilber and Crete will be unveiled as the eclipse comes closer.
