Vendor Rules and Guidelines

Vendors may register for one business per booth; sharing booths is not allowed. All booths must be ready **at 9:00 a.m.**, September 28th, and remain open until 3 p.m.

Deviation from items listed on your application could result in the closing of your booth.

There will be no rain date. A registration is a commitment to show.

Each exhibitor must provide his or her own display. Freestanding canopies are recommended, come prepared for any weather. You must bring your own tables and chairs.

Exhibitors are responsible for their own clean-up including the removal of all boxes and over-sized trash items. Trash generated by the vendor during the event must be removed from site, not dumped in public trash cans. All booths must remain clean and presentable at all times.

Single booth dimensions are 10' x 10'. Spaces will be on asphalt or grass. Some spots may have uneven terrain within the assigned space. Come prepared. Electricity is limited. We recommend quiet generators.

Your display should be attractive and operated in good taste. No participant may sell illegal or immoral items. The White County Chamber of Commerce & Welcome Center reserves the right to disallow selling of disruptive, dangerous, damaging, etc. items. Anyone in violation of these restrictions will be escorted off the premises immediately. **THIS IS A FAMILY ORIENTED EVENT.**

No participant may sell items bearing insignia pertaining to the White County Chamber of Commerce & Welcome Center, the City of Cleveland or White County government.
