### Awards

Awards will be presented to the 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place overall winners, as well as 1<sup>st</sup> place winners for 50+ and for 18 & Under, in the following categories:

1-Mile Race – Men's, Women's

3-Mile Race – Men's Displacement, Women's Displacement, Men's Surfstyle, and Women's Surfstyle

6-Mile Race – 14' Men's Elite, 12'6" Men's Elite, and 12'6" Women's Elite

Medals will be given to the top boy and girl in the Kids' Fun Paddle, which is for kids 12 and under.

### **WAIVER, RELEASE OF LIABILITY AND COVENANT NOT TO SUE**

1. Prior to participating, I will inspect the launch/tournament area and any equipment to be used, and if I believe anything is unsafe, I will immediately advise an agent or employee of Bote Board and the Destin Chamber of Commerce of the existence of such condition(s) and refuse to participate.
2. I acknowledge and fully understand that I will be engaging in activities that involve risk of damage to personal property, or serious injury, including permanent disability and death, and severe social and economic losses which might result not only from my own actions, inactions or negligence, but the actions, inactions or negligence of others, as a result of paddleboard, racing, wading in the water and swimming, including but not limited to perils of sea and waterways, acts of other participants, adverse sea and weather conditions, and I hereby assume complete responsibility and liability for such risks. Further, there may be other risks not known or not reasonably foreseeable at this time.
3. I do hereby release, waive, discharge and COVENANT NOT TO SUE the Destin Chamber of Commerce, Inc., Bote Board LLC and its directors, agents, employees, sponsors or any other individual in any way associated with the Destin Chamber of Commerce, Inc and Bote Board LLC, all of which are hereinafter referred to as "Releasees", from any and all liability to me, my heirs and next of kin for any and all claims, demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence or any other actions of the Releasees or otherwise.
4. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation.
