 - **\$50.00 for each 10X10 space, if paid at least 7 days prior to the show, \$75 anytime later than 7 days prior to show.**
 - **Vendors can begin setting up between 1:00 –2:30 pm. You will be notified of booth location upon arrival.**
 - **Due to safety reasons, vendor vehicles must be out of the vendor area by 2:30 pm and will not be allowed to return into the event area until 8:00 pm.**

STRAWBERRY CLASSIC CAR SHOW RULES & REGULATIONS

- **All vendors must have their booth and merchandise in their assigned location by 2:30 PM and be ready to do business by 3:00 PM.**
- Vendors will remain in operation until 8:00 PM or until released by Chamber staff.
- Chamber staff will assign vendor locations on day of event.
- **Contract and payment are due by the Friday the week before each Car Show. If payment is made later than 7 days prior to the show, additional fee of \$25.00 will be charged per vendor.**
- On the day of the event, in case of extreme emergency, if a vendor is not able to attend a show, please advise Laura, Vendor Coordinator, at (847) 609-0927.
- Normal policy is to limit the number of certain food, drink and refreshment items at each event. The committee reserves the right in the case of larger events to add vendors of food, drink and refreshment items.
- **Strawberry Classic Cruise-In event takes place rain or shine, NO REFUNDS OR CARRYOVERS.**
- **Food Vendors are expected to serve only those items from their menu that have prior approval by the committee.**
- The Greater Plant City Chamber of Commerce and /or Strawberry Classic Cruise-In Committee reserves the right to sell promotional merchandise and refreshments in their booths at all sponsored events.
- **Vehicles and equipment not used in the sale of food or merchandise must be removed from the event area by 2:30PM.**
- Each vendor is responsible for the cleanliness of his or her area. Trash receptacles and bags are available at the RR Tower building. Trash receptacles are the property of the City of Plant City and must remain in the Car Show area.
- All vendors are expected to respect the rights of each other and the event participants.
- Any policy changes in the future will be shared with vendors in writing.

The Car Show Committee's goal is to sponsor an event that is welcoming, appealing, and beneficial to all involved. The Car Show Committee reserves the right to make adjustments in the above policy, as emergency situations require. We welcome all comments and ideas.
