### Outstanding Business



Given to a business that has made a substantial contribution to the lasting enhancement of Palo Alto while demonstrating exceptional leadership and community involvement.

### Outstanding Professional or Business Person



Given to a professional or business person who, through extraordinary efforts in his or her chosen field, has contributed significantly to the Palo Alto community.

### Outstanding Nonprofit



Given to a nonprofit organization that has made a substantial contribution to the lasting enhancement of Palo Alto while demonstrating exceptional leadership and community involvement.
