2019 PIG IN THE PINES ARTISAN MARKET EXHIBITOR GUIDELINES

Space Rental Fee

- Space fees are \$100 prior to 7/5/19 and \$115 after 7/6/2019.
- The fee **MUST** be paid in full before a space will be assigned. No post-dated checks will be accepted. A \$30 service charge will be assessed for any check returned to us for non-sufficient funds. We accept all major credit cards, there is a \$3.00 processing fee for credit card and PayPal Transactions.
- ***All space contracts are non-refundable and non-transferable.***
- Spaces are assigned on a first come, first serve basis.
- Any application received after 7/26/19 must be paid with cash or credit card.

Space Appearance

- No chairs or displays are allowed outside your assigned space.
- All displays and exhibits must comply with the rules and regulations of the local fire department. Fire exits, alleys and aisles must be kept open at all times.
- No tables or other equipment will be provided or rented to exhibitors.
- All trash from your space must be disposed of prior to your departure. There are ample trash receptacles available on the grounds.

Show Times and Rules

- **Set -up time begins at 9:00 AM for Pig in the Pines.**
- Show hours are 11:30 AM - 6:00 PM both days.
- **NO PETS ALLOWED ON-SITE!**
- Exhibitors must begin set-up 1 hour prior to show starting time. Any exhibitors who have not begun set-up 1 hour prior to show starting time will be considered a **no-show** and the space will be re-assigned.
- Exhibitors must be ready for business a ½ hour prior to show starting time, no exceptions.
- You may park near your space for unloading, but you must move your vehicle to the main parking lot during the show. **THERE WILL BE NO EXCEPTIONS.**
- All Exhibitors vehicles must be moved to the assigned parking area by 11:00 AM.
- Exhibitors may not begin dismantling until the posted closing time of 6:00 PM. **Early removal is strictly prohibited and will jeopardize the exhibitor's chance of being invited to future shows.**
- Exhibitors may stay later if they wish.

Juried Requirements:

- Only handcrafted items made by the seller may be displayed for sale.
- Imports, manufactured items or screen print will not be accepted.
- All applications must include the following.
 1. Payment in full. We accept checks, money orders, cash, credit cards and PayPal.
 2. **A self-addressed, stamped envelope** large enough for the return of your photos and confirmation. Minimum size 4-1/8" x 9-1/2".
 3. **Photos of your work in progress and finished product.** Some photos must show work during the creation process. Photos showing only complete work will not qualify.
 4. Your Wisconsin Tax Account Number or Social Security Number. State law requires us to report the names of all show participants to the Wisconsin Department of Revenue.
- Your application will not be processed if ANY of the above listed items are missing.

Harassment or verbal abuse of anyone associated with the event or guests is strictly prohibited. Any complaints regarding such conduct will result in the removal of the exhibitor.

Please have business cards or other materials with your name, address, phone number and business available for customers. Often we receive phone inquiries after the show from potential customers. We cannot guarantee that we will be able to provide them with your information.

By St. Germain Town Ordinance, no carry-ins of any alcoholic beverages will be permitted and no overnight parking will be allowed in any Town Park in St. Germain.
