## **Multiple Business Membership Policy**

Do you own more than one business? You can have all of the businesses listed as separate members for just \$60 per additional business. Choose one business as your primary business and pay dues on that business based on the total of all employees from all businesses. Each additional business after the primary business pays a flat \$60.

## **Individual Realtor Policy**

Individual realtor should be included in the employee count of their broker's membership. Individual realtors may receive all mailings from the Chamber for additional \$25 if they represent a broker who is a member in good standing. Individual realtor listings should be included with and paid for at the same time as the broker dues.

\* The investment for 1-8 employees includes one representative on the membership roster, 9-19 employees includes two representatives, 20-49 employees includes three representatives, and 50 + employees includes four representatives. Please note that business owners are considered "employees." Representatives receive the monthly Chamber newsletter as well as event and program notifications. All professionals who pay \$60 add'l investment will be listed. There is a \$25.00 fee to add additional representative(s).

\*\* **Employees** mean full time equivalent employees (FTE's), **including owners, managers, and independent contractors.**

Two part time employees (32 hours or less) equal one FTE.

*This investment schedule has been adopted by the Board of Directors to assure fair and equitable financial participation by all members. Effective 11/1/17*
