BUSINESS TO BUSINESS LEADS GROUP



WHAT IS A LEADS GROUP?

A leads group is a business to business referral networking group where there is only one member per professional category. Members meet twice per month to exchange business leads. It is one of the best strategies for building your business.

WHY DO LEADS GROUPS WORK?

Leads groups work because the purpose of the group is to pass business leads and build relationships with other Chamber members. There is an expectation that you will provide warm leads, not cold calls.

SHCC LEADS GROUP PURPOSE STATEMENT

"We are a group of business professionals of the Safety Harbor Chamber of Commerce with the intent to improve the success of our members through networking and building relationships with each other and within the community."

LEADS GROUP GUIDELINES

Business to Business LEADS Group members must be current members of the Safety Harbor Chamber of Commerce. If a LEADS Group member cancels membership in the Safety Harbor Chamber of Commerce, membership in the LEADS Group will be discontinued.

LEADS Group members must fill out a LEADS Group Program Application and pay \$75 for an entire year. Membership in the LEADS Group will be for one year from the first day of the month in which application and payment is received. Failure to pay the LEADS membership may result in becoming inactive and/or removed from the group. Only one member is allowed from each business category. Business category must be approved by the Chamber President. When a seat becomes available, Chamber members in that business category will be notified of the vacancy before a non-member is invited to join. **Each group will have a maximum of 20 members.**

The success of any leads group is dependent upon participation. To insure the group is valuable to all participants, **members may only miss four scheduled LEADS meetings per year.** After the 4th absence your seat will be made available. Members may however send another representative from their business in their place. If the member business is not able to send a representative, a substitute from another business may be sent to attend the meeting. If the substitute represents a business category that is already occupied in the group, the substitute may not speak about their business other than an introduction of their name and company name. **If a member is more than 10 minutes late to a meeting it is considered an absence.**

Members are encouraged to bring guests from an unoccupied business category. Guests may attend twice before being asked to make the decision to join the group.

During each one hour group meeting, members present a 60 second business introduction. Additionally, group members can sign up for a 10-minute business presentation, with two presentations during each meeting.

These guidelines are subject to change with written notice to the groups.
