There are multiple scholarships offered: Scholarships will be awarded directly to the institution of choice after registration is confirmed for Fall 2020.

Entry & Eligibility Requirements

1. Fill out the application completely.
2. Enclose a letter not longer than 500 words stating your interest in a scholarship.
3. Return the application and letter by the deadline date indicated at the bottom of your application.
4. Must be Washington Resident
5. Enrolled in their senior year with path to Graduation from one of the Greater Spokane Valley schools to include:
 - a. West Valley High School
 - b. East Valley High School
 - c. Central Valley High School
 - d. University High School
 - e. Freeman High School
 - f. Ridgeline High School
 - g. Completion of Equivalent Studies – Independent, private or home school

Award Process

1. The scholarship awards will be selected upon receipt by a panel unrelated to the applicants and will include members of the Chamber Foundation. Applications will be viewed starting on January 15 and completion of review on April 15. Preference is given for early applications.
2. All awards decisions of the panel are final and irrevocable. Should an award recipient not be able to use a scholarship, a runner-up may be selected.
3. The award will be presented to the scholarship winners in writing as well as their selected institution.
