SHOW RULES INDEMNITY AND RELEASE AGREEMENT

1) NO LOADED GUNS ARE ALLOWED INSIDE THE BUILDING AT ANY TIME.

This is not negotiable! Unload your guns, magazines, and clips BEFORE you enter the building. Check every gun on your table often. If a peace officer finds you with a loaded gun in the building, you are subject to arrest and very well may go to jail. If you have a concealed carry license, you may face a suspension of that license. Show management reserves the right to check all bags, purses, and containers to ensure that no firearms or prohibited materials are being brought into the show by dealers or patrons.

2) NO CAMERAS, TAPE RECORDERS, OR OTHER RECORDING DEVICES

Are permitted in the show without prior authorization by GCCOC (Greater Cleveland Chamber of Commerce) staff. You may contact them at 281-592-8786.

3) GUN TYING AND SAFETY MEASURES

All firearms that fire fixed ammunition should be checked, cleared, and tied in an inoperable position. This rule is not negotiable! Dealers are responsible for tying of their own firearms.

4) SAFETY RULES

BE CAREFUL, USE COMMON SENSE, AND ALWAYS OBEY THE FOLLOWING RULES:

- Never load any firearm in the show for any reason.
- Treat all guns as if they were loaded
- Never point a gun at anything you are not willing to destroy
- Keep your finger off the trigger

5) GENERAL

Obey all applicable federal, state, and local laws, rules, ordinances, and regulations. If you have any questions about these laws, consult your attorney for advice. Show exhibitors are expected to make only factual representations regarding the quality and authenticity of the items displayed and sold at the show.

6) RECORD KEEPING AND IDENTIFICATION

No sign(s) or written notice may be displayed by dealer or seller that states that any firearm offered for sale are part of a private collection and are not subject to record-keeping, identification and/or background checks. Any non-licensed seller of firearms must positively determine identification, residency, and age of buyer by a governmental agency issued ID. Sales of a handgun can only be to a TEXAS RESIDENT 21 YEARS OF AGE OR OLDER. Sales of rifles and shotguns can only be made to a PERSON 18 YEARS OF AGE OR OLDER.

7) MERCHANDISE

- GUNS - We primarily want dealers who sell guns and gun related items.
- AMMUNITION - Powder and primers are allowed, all ammunition must be in sealed packages.
- HUNTING - Items relevant hunting (bow, garments, etc.
- JEWELRY - Jewelry is allowed (Limited Vendors)

ARTS & BOOKS - Preferred gun-related (Gun, Hunting, Wildlife, Western, American Indian, or Military). Books can not contain adult and/or sexually related subjects.

8) CANCELLATIONS, REFUNDS, ROLLOVERS

WE do NOT want vacant or empty tables. Call the chamber at 281-592-8786 or e-mail info@clevelandtxchamber.com if you have a problem. Refunds are available if cancellation is made prior to August 11, 2017. No refunds will be made after that date. Tables must be set up and ready by 8:30 am, Saturday, 6/16/18 or they will be considered "Unclaimed". Unclaimed table (s) will be forfeited at 8:30 am on Saturday, June 16, 2018, unless you have made prior arrangements for late arrival. If your table has been forfeited we are not responsible for any loss of profit, sales, expenditures, rental refunds and/or any related damages.

9) RESERVATION

You may reserve your same table(s) for the next show when you check in. We highly encourage reserving your space for future shows at time of check in, or before end of current show.

10) SHOW HOURS

Actual hours of the gun show are Saturday, June 16, 2018 from 9:00am to 5:00pm. No packing or breakdown is permitted before the end of the show (5:00 pm Saturday, June 16, 2018)

11) ATTENDANCE

All vendors/dealers must man their table(s) during show hours. If a situation occurs and you must leave early, you must exit through personnel doors at the back of the room or doors approved by GCCOC (Greater Cleveland Chamber of Commerce) staff. Rear doors of the Civic Center must remain closed and locked at all times during show hours. If you must exit the back doors for any reason you may not leave door (tied open or blocked open).

12) AGES

No one under the age of 18 will be admitted into the show unless accompanied by an adult

13) RELEASE

The Lock-N-Load Gun Show and all employees and volunteers of the Greater Cleveland Chamber of Commerce. Cleveland Senior Citizens Organization and/or the City of Cleveland is hereby released from any and all damages that may occur before or during the show. All dealers/vendors/exhibitors and/or individual must assume responsibility to make sure these rules are followed at all times. Violation of any of the above rules may result in the immediate expulsion from the show and forfeiture of your table (s) and can also be banned from future shows.
