1. For a fee of \$30.00 (to cover the cost of advertising and insurance) the Berwyn Development Corporation agrees to reserve a booth space of not less than 10 Feet by 10 Feet. Participants must provide their own tent/booth/tables/chairs, and any signage. Space will be assigned upon receipt of pre-paid vendor fee. Participants can have the use of one parking space next to their booth for the use of their vehicle. Any extra(s) vehicle(s) helping to load or unload needs to be removed prior to 8 a.m. but may come back after 3 p.m. to help load any necessary items.
2. Each Participant is responsible for setup and removal of all equipment and other items used for the event, removal of unsold items at the end of the event, and removal of all trash from the assigned area at the end of the event.
3. Setup of equipment by Participant will begin no earlier than 7:00 a.m. on Saturday, June 1, 2019, and must be completed by 8:00 a.m. of that same day. **Space assignment begins on the 4th level of the parking deck, specific spaces cannot be requested. Please be aware of the height restriction of 7 feet, please plan accordingly.** Take down of equipment will begin no sooner than 3:00 p.m. of that same day, unless the BDC determines otherwise. All Participant equipment and excess trash must be removed no later than 4:00 p.m. of that same day.
4. Each Participant must conduct themselves in an acceptable and orderly manner. Your selling area must be kept clean at all times.



5. By execution of this registration form, the undersigned Participant releases and discharges the Berwyn Development Corporation, its officers, employees, agents, representatives and servants and/or anyone else connected with management and representation of the Depot District of and from any and all known or unknown damages, injuries losses, judgments and/or claims from any case whatsoever that may be suffered by a registrant to his or her person or property. Further, each registrant expressly agrees to indemnify the City of Berwyn, its officers, employees, agents, representatives and other registrants or firms.
6. Violation by Participant of any terms of this agreement or any specific event rules as set forth by the Berwyn Development Corporation will render this contract void. Upon such violation, the Berwyn Development Corporation may, at its discretion, require Participant to immediately cease operation at the event, and, within a reasonable period of time, remove all items and equipment, without reimbursement of any expenses or fees paid by Participant.

Deadline for returning this agreement to the Berwyn Development Corporation is **May 31, 2019**.
