### **REGISTRATION & BOOTH INFO:**

There is a fee of \$35 per 10'x10' space if your application is received by Fri, August 31<sup>st</sup>. If received after this date, the fee is \$40 per 10'x10' space. ***You will need to provide everything you need to set up including tables, chairs, displays and tent if desired. Be prepared for all weather conditions as there are NO REFUNDS.*** If you want the same space as last year, please note the space #, or just put "same location" on your application and send in by deadline specified below. We will do our very best to accommodate any special requests. There is **NO APPROVED ELECTRICITY** available for use in the craft and flea market areas.

### **SALES TAX:**

All vendors must collect 6% Kentucky sales tax. You may include the tax in your price. If you do not have a Kentucky sales tax number, you must collect the tax and place in the tax envelope, which will be provided for you the day of the show.

### **CHECK-IN, SET UP & TAKING DOWN:**

Check-in will begin at 6:00 a.m. ***All vendors must check in on the Courthouse front steps.*** By checking in, you will be assured that you have the correct location to set-up and avoid being moved later. You must be set up and ready for customers by 9:00 a.m. The show is from 9:00a to 4:00p. We ask that you keep your booth up and open until 4:00pm. Taking down early looks bad on the show and the vendors around you. After dropping off your set-up and goods, you will need to move your vehicle asap. All vendors need to park in the Market Square (Family Dollar) parking lot, located across the street, behind the Historic Courthouse. ***There is absolutely no parking on Winter Street beside the Courthouse, on 4<sup>th</sup> Street, or in the Courthouse parking lot during any part of the day.***

### **REGISTRATION:**

Complete the enclosed form and return with your check made payable to the Logan County Tobacco & Heritage Festival. Booth assignments will be on a first come, first serve basis. **You will have first choice on reservation if you want the same spot you had last year, until the deadline of August 31<sup>st</sup>. After this date, booths are open to new vendors.** Confirmation on space assignments will be sent by late September.

**Confirmation letters with location map will be sent by EMAIL. Please make sure application (attached) is filled out completely and legibly. We look forward to having you at our show, once again!**
