Biloxi Chamber of Commerce Nonprofit Grant Program

Nonprofits look for opportunities to improve our community. Biloxi Chamber of Commerce has instituted a program designed to assist nonprofits with development and expansion. Biloxi Chamber of Commerce's Nonprofit Grant Program will provide financial support for its membership. Grants will be awarded to selected nonprofits in the Biloxi Chamber of Commerce service area who meet the specified criteria. Applicants who have not received a Biloxi Chamber of Commerce Grant in the past 3 years will be considered first.

Applications will be judged in the following categories:

- Grant funds will increase nonprofit exposure.
- Grant funds will increase nonprofit capacity.
- Grant funds will positively impact City and surrounding businesses.
- Plans for spending grant funds are clearly defined.

To apply, review the guidelines below and complete the application on the opposite side of this form. You must provide all requested information to be eligible.

To be eligible for the mid-year distribution, a completed application must be received at the Biloxi Chamber of Commerce office no later than 5:00 p.m. on May 23, 2019.

To be eligible for the end of the year distribution, a completed application must be received at the Biloxi Chamber of Commerce office no later than 5:00 p.m., October 24, 2019.

Any applications received after the mid-year due date may be considered for the end of the year distribution, including those received in the mail. Completed applications may be dropped off in person or mailed to: Biloxi Chamber of Commerce Grant, 11975 Seaway Road, B120, Gulfport, MS 39503.

- _____ 1. Biloxi Chamber of Commerce is an affiliate of Mississippi Gulf Coast Chamber of Commerce, Inc. Becoming a member of Mississippi Gulf Coast Chamber of Commerce, Inc. is synonymous with Biloxi Chamber of Commerce membership. Call 228-604-0014 to join. **To be eligible for the Biloxi Chamber of Commerce Nonprofit Grant Program you must be a member of the Mississippi Gulf Coast Chamber of Commerce, Inc.**
- _____ 2. The award may be granted to selected small businesses currently operating or reopening by grant submission date, in the City of Biloxi or Biloxi Chamber of Commerce Service Area (includes D'Iberville and Ocean Springs).
- _____ 3. Applicants must complete the entire application, and it must be typed or written clearly. Please include as much detail as possible.
- _____ 4. Application for the grant gives permission for the Biloxi Chamber of Commerce Board of Directors, staff or a designee to visit the nonprofit for evaluation.
- _____ 5. To be eligible, applicants must be operating a business in the Biloxi Chamber Service Area (39530, 39531, 39532, 39540, 39564) and be a member of Biloxi Chamber of Commerce by the corresponding due date.
- _____ 6. Nonprofit must have 50 full time employees or less.
- _____ 7. Applications must be received in the Biloxi Chamber of Commerce office no later than 5:00 p.m., by the corresponding due date.
- _____ 8. Applicants must include a brochure, business card or flyer that adequately describes the nonprofit.

The decisions of the selection committee will be final.

The Biloxi Chamber of Commerce reserves the right to limit applications, modify or change the program at any time.
